CARRIER SHIPMENT CONFIRMATION – QUICK PAY OPTIONS

PAYMENT TERMS: At Backhaul Direct, we understand how expensive it is to run a trucking company. We also feel that carriers should be paid fairly, quickly, and in full upon delivery. Generally, we pay our carriers 30 days from the day we receive an invoice, but if you are in need of a Fuel Advance or Quick Pay, we are pleased to offer these options to our qualified carriers.

PLEASE NOTE: NO FIRST TIME CARRIERS WILL QUALIFY FOR A FUEL ADVANCE

_____ **FUEL ADVANCE:** Backhaul Direct offers its carriers the opportunity to take advances on payment after loading. A Com-Check will be given after loading for 40% of the negotiated rate less 5% OR a \$20 fee, whichever is *GREATER*. Please note that Fuel Advances will only be given after there has been verification with the shipper or a clean and signed Bill of Lading (BOL) has been faxed.

_____ **QUICK PAY OPTION #1:** (Regular mail by next business day) - Upon evidence of a Proof of Delivery (POD), both faxed and followed up by a verification phone call to the consignee, Backhaul Direct will mail the carrier a check for the billed rate less 3% OR a \$20 fee, whichever is *GREATER*. This check will be mailed by the following business day via the United States Postal Service.

_____ **QUICK PAY OPTION #2:** (FedEx same day if received by 13:00 EST) – Upon evidence of a Proof of Delivery (POD) by 13:00 EST, both faxed and followed up by a verification phone call to the consignee, Backhaul Direct will expedite the carrier a check for the billed rate less 3% OR a \$20 fee, whichever is *GREATER* PLUS a \$25.00 handling fee. Your check will be sent out via FedEx the day Backhaul Direct receives the request.

_____ **QUICK PAY OPTION #3:** (Com-Check same day) – Upon evidence of a Proof of Delivery (POD), both faxed and followed up by a verification phone call to the consignee, Backhaul Direct will issue the carrier a Com-Check for the total billed rate less 5% OR a \$20 fee, whichever is *GREATER*.

THESE FEES, AT A MINIMUM, CAN BE \$4.25 PER \$1,000.00 PER TRANSACTION. THESE FEES ARE NOT CONTROLLED BY BACKHAUL DIRECT AND ARE SEPARATE FROM ANY RATE NEGOTIATIONS BETWEEN CARRIER AND BACKHAUL DIRECT.
